JUSNL is a company constituted under the provisions of Government of Jharkhand, General Resolution as notified by transfer scheme vide notification no. 8, dated 6<sup>th</sup> January 2014. The Transmission Company - Jharkhand Urja Sancharan Nigam Ltd. is duly registered with the Registrar of Companies, Ranchi on 23<sup>rd</sup> October 2013.

In accordance with the provisions the JSERC (Terms and Conditions for Determination of Transmission Tariff) Regulations, 2015 and other relevant Acts/ Regulations/ Policies, JUSNL has filed the Petition for True-up for FY 2017-18.

The Commission has scrutinized the Petition and has directed JUSNL to publish a public notice for inviting objections/comments from various stakeholders.
