

The Petitioner respectfully submits as under:

1. Jharkhand Urja Sancharan Nigam Ltd. (herein after to be referred to as "JUSNL" or "the Petitioner" has been incorporated on 23rd October 2013 with the Registrar of Companies, Jharkhand, Ranchi and has obtained Certificate of Commencement of Business on 28th November 2013. The Petitioner is a Company constituted under the provisions of Government of Jharkhand, General Resolution as notified by transfer scheme vide notification no. 8, dated 6th January 2014.
2. JUSNL had filed a True-up Petition before the Hon'ble Jharkhand State Electricity Regulatory Commission for approval of the True-Up for the FY 2015-16 and FY 2016-17 as per the Electricity Act, 2003 and as per the provisions of the Terms and Conditions for JSERC Transmission Tariff Regulations.
3. Hon'ble Jharkhand Electricity Regulatory Commission has on 30.12.2020 issued its Order on the aforesaid Jharkhand Urja Sancharan Nigam Limited (JUSNL)'s True-Up Petition for FY 2015-16 and FY 2016-17.

4. The Petitioner has analysed the Order given by the Hon'ble Commission and based on our understanding, the Petitioner believes that certain aspect in the True-Up Order is not in line with the intent of the Regulations and ought to be reviewed.
5. By means of this Petition, the Petitioner is submitting its observations on the aforesaid points which needs to be reviewed in line with the provisions of the Regulations and prudent industry practices. The submissions are provided in the following paragraphs.

Power of the Commission to Review its decisions

6. The Petitioner submits that Regulation 41.1 of JSERC (Conduct of Business) Regulations, 2016 provides the power to this Hon'ble Commission to review its orders. The relevant excerpts of the regulations are reproduced below for reference:

"A41: REVIEW OF THE DECISIONS, DIRECTIONS AND ORDERS

41.1 The Commission may at any time, on its own motion, or on an application of any of the person(s) or parties concerned, within 30 days of the making of such decision, directions or order, review such decision, directions or orders and pass such appropriate orders as the Commission deem fit.

Provided that power to review by the Commission on its own motion under this clause may be exercised only for correction of clerical or arithmetical mistakes arising from any accidental slip or omission..."

7. Jharkhand State Electricity Regulatory Commission's (Conduct of Business) Regulations, 2016 provide for a time period of 30 days from the Order within which Jharkhand Urja Sancharan Nigam Limited (JUSNL) can file for the Review Petition against the Order.
8. Jharkhand Urja Sancharan Nigam Limited (JUSNL) had vide letter no. 30 dated 16.03.2022 requested for an additional time period upto 31th May, 2022 for filing aforesaid Review Petition. Jharkhand Urja Sancharan Nigam Limited (JUSNL) is hereby submitting the Review Petition within the additional time sought.

Facts of the Case

A. Capital Expenditure and Capital Works in Progress during the Year

9. The Hon'ble Commission has in the Order not discussed about the addition to CWIP or capital expenditure during the year for FY 2015-16 and FY 2016-17 in its Order dated 30.12.2020.

10. Before proceeding further, the Petitioner would like to most humbly submit that the CWIP has not been completely represented under the corresponding line item in its Accounts for the respective years. As per generally accepted accounting principles, loans and advances, capital advances, advances to suppliers and stocks of material at capital site are considered part of Capital Work in Progress. In the Annual Accounts for FY 2015-16 and FY 2016-17, CWIP has been listed under four-line items which can be traced back from the Transfer Scheme:

- i. Capital Works in Progress (the same has been detailed under Note No. 13 in Audited Accounts for FY 2015-16 and FY 2016-17)
- ii. Long - term loans and advances under the sub - item – “Capital Advances” (the same has been detailed under Note No. 15 in Audited Accounts for FY 2015-16 and FY 2016-17)
- iii. Short – term loans and advances under the sub – item – “Advance to Suppliers” (the same has been detailed under Note No. 21 in Audited Accounts for FY 2015-16 and Note No. 18 in Audited Accounts for FY 2016-17)
- iv. Inventories under the sub item – Stock of Materials at Construction Site (Capital) (the same has been detailed under Note No. 18 in Accounts for FY 2015-16 and Note No. 17 in Accounts for FY 2016-17)

11. The above submission was also made during the processing of the Review Petition filed against True-Up Order for FY 2013-14 and FY 2014-15. The Hon'ble Commission in the Review Order dated 03.12.2020 also accepted the plea of the Petitioner and found it prudent to allow this as per the Audited Annual Accounts for respective years.

12. This incomplete capturing of CWIP under the line item “CWIP” in the Accounts has led to the same being “under- submitted” in the True Up Petition. The Petitioner would like to correct the same in this Review Petition as detailed in the following Table.

* As per Audited Accounts, the figure is Rs. 1038.60 Crore. However, an amount of Rs. 11.57 Crore is added to the same which was not capitalised during FY 2014-15 and was left in closing CWIP for FY 2014-15. Hence Rs. 1050.07 Crore is the same amount which the Commission allowed as closing CWIP for FY 2014 -15 in its Order of Review Petition for True UP for FY 2013 -14 and FY 2014-15 dated December 03, 2020.

13. The Petitioner hereby requests the Hon'ble Commission to kindly approve the "Capital Expenditure during the Year" for FY 2015-16 and FY 2016-17 as per the above submission.

B. Capitalisation during the year / Addition to GFA

14. The Petitioner had claimed the capitalisation of INR 298.89 Crore and INR 43.31 Crore during the year for FY 2015-16 and FY 2016-17 in line with the annual audited accounts. The Hon'ble Commission vide its letter dated 05.12.2018 directed the Petitioner to submit the scheme wise detail of capitalization for FY 2015-16 and FY 2016-17. In compliance to Commission's direction, the Petitioner submitted the scheme wise details of capitalization vide its letters dated 10.05.2019 and 05.12.2019.

15. The Hon'ble Commission scrutinized the detail submitted by the Petitioner and disallowed INR 0.64 Crore for FY 2015-16 and INR 0.70 Crore for FY 2016-17 in its Order dated 30.12.2020 in view of absence of supporting documents.

16. The Petitioner hereby requests the Hon'ble Commission to allow submission of details of capitalisation of INR 298.89 Crore and INR 43.31 Crore during the year for FY 2015-16 and FY 2016-17 in line with the annual audited accounts.

17. It is to be noted that details of capitalisation are not directly maintained at the head quarters of JUSNL. It is being compiled while preparing the annual accounts for the year. Collection of information regarding the capitalisation at various filed units requires meticulous effort and is a time-consuming exercise. Any disallowance of capitalisation shall have direct impact on the tariff of the Petitioner and shall lead to under recovery.

18. Therefore, in view of the above, the Hon'ble Commission is requested to consider the details provided as **Annexure-I** of this Petition and approve capitalisation of INR 298.89 Crore and INR 43.31 Crore for FY 2015-16 and FY 2016-17 respectively in line with the annual audited accounts.


The petitioner respectfully prays before the Hon'ble Commission may:



1. The Hon'ble Commission vide its Order dated December 03, 2020 in the matter of review of the Order dated 01.02.2019 for True up of FY 2013-14 (6th January 2014 to 31st March 2014) and FY 2014-15 approved the True Up of FY 2013-14 and FY 2014-15 of JUSNL.
2. The Hon'ble Commission as against claim for addition in GFA for FY 2014-15 of Rs. 557.17 Crore approved Rs. 545.70 Crore ruling that:
 39. The assets of Rs. 11.57 Cr (difference of Rs. 557.17 Cr as submitted by Petitioner and Rs. 545.70 Cr) has been disallowed for FY 2014-15. Due to non-submission of any details, the Commission is unable to review the same.
3. The Petitioner would like to bring to the kind notice of the Hon'ble Commission that it has compiled division wise Asset capitalization details for FY 2014-15 and the same is attached at **Annexure-'B'**. The petitioner humbly submits that complete scheme-wise capitalization details of FY 2014-15 to the tune of Rs.557.17 Cr. has been received after the submission of Review Petition for FY 2015-16 & FY 2016-17 before Hon'ble Commission vide dated 30.03.2022.
